

# Youth Volunteer Award 2019

---

## NOMINATION FORM

The Selection Board of the National Volunteer Award, appointed by the Malta Council for the Voluntary Sector, will receive nominations for this award made through this form, in line with the regulations outlined below.

### A. REGULATIONS

#### 1. The aim of the Award

- 1.1 The **Youth Volunteer Award** is for Volunteers between the ages of 16 and 30.
- 1.2 This award has the main scope to promote volunteering amongst young people and shall have the same aims as the National Volunteer Award, hence:
  - 1.2.1 To give broad recognition to the service done by volunteers,
  - 1.2.2 To create awareness of the exemplary values displayed by the nominee,
  - 1.2.3 To recognise the important contribution the nominee has made by volunteering in some field.

#### 2. Eligibility criteria

- 2.1 Nominees must be Maltese nationals or legally recognized residents in Malta, for the past five calendar years.
- 2.2 Nominees must be aged between 16 and 30 by the closing date for nominations.
- 2.3 Nominees should have undertaken active voluntary work between the whole period from January of the current year and the closing date of this application.
- 2.4 Nominees must have a clean police conduct.
- 2.5 This is a once-in-a-lifetime award: previous winners are not eligible for nomination.
- 2.6 Nominees should not be PEPs (*kindly refer to the definition below*).

### 3. Conditions for participation

- 3.1 The voluntary work may be in any field, such as sports, social, humanitarian, ecological, cultural etc., but must be in line with human rights and the laws of Malta. The Malta Council for the Voluntary Sector reserves the right to refuse nominations on ethical grounds.
- 3.2 The voluntary work must have made some positive contribution towards a particular field and should ideally have served as an inspiration for others.
- 3.3 Nominators implicitly attest that the nominee does not make financial gains through the voluntary work done for the VO, and has a clean police conduct.

### 4. The nomination process

- 4.1 A nomination should be made by two persons who know the nominee through work or other activities, and endorsed by an Administrator of the nominating VO.
- 4.2 Each nomination must clearly show that the nominee is qualified to compete for the Award. The form must be signed by both nominators.

## ***Definition of a politically exposed person (PEP)***

*For the purposes of this application PEP refers to:*

*(a) individuals who are or have been entrusted with prominent public functions include the following—*

- *(i) heads of state, heads of government, ministers and deputy or assistant ministers;*
- *(ii) members of parliaments;*
- *(iii) members of supreme courts, of constitutional courts or of other high-level judicial bodies whose decisions are not generally subject to further appeal, other than in exceptional circumstances;*
- *(iv) members of courts of auditors or of the boards of central banks;*
- *(v) ambassadors, chargés d'affaires and high-ranking officers in the armed forces; and*
- *(vi) members of the administrative, management or supervisory bodies of state-owned enterprises;*

*(b) immediate family members including the following—*

- *(i) a spouse;*
- *(ii) a partner;*
- *(iii) children and their spouses or partners; and*
- *(iv) parents;*

*(c) persons known to be close associates include the following—*

*(i) any individual who is known to have **joint beneficial ownership** of a legal entity or legal arrangement, or any other close business relations, with a person referred to in regulation (a); and*

*(ii) any individual who has **sole beneficial ownership** of a legal entity or legal arrangement which is known to have been set up for the benefit of a person referred to in regulation (a).*
