
Through these years, starting from nothing but the desire to work in favour of the evergrowing sector, MCVS set its goals and objectives which in such a short time were converted in some remarkable achievements. Some of the landmark achievements which must be mentioned are the organisation of the European Year for Volunteering 2011; it's first funding line – the Small Initiatives Support Scheme (SIS) followed by the managing of various other schemes namely the Training Initiatives Scheme (TIS), the Civil Society Funf (CSF), the Voluntary Organisations Projects Scheme (YVWS) and the Voluntary Organisations Projects Scheme (VOPS); the National Volunteer Award; the setting up of an online VO Directory; the setting up of its web portals; the annual training conferences; the opening of three Volunteer Centres; the setting up of the fisrt one stop shop for VO funding online portal – the vofunding.org.mt and regular contact and information meetings with VOs.

Is the work done, of course not! MCVS looks forward to more work in favour of the sector with your participation and contribution.

# Successful Project closure by VOs funded under the

**Voluntary Organisations Project Scheme (VOPS)** 

n Friday the 22nd June 2018 the Hon. Dr. Clifton Grima, Parliamentary Secretary for Youth, Sports and Voluntary Organisation in a ceremony at the Voluntary Centre in Valletta, in the presence of Mr Mauro Pace Parascandalo, Executive Director, MCVS, brought to a close three projects funded by the Voluntary Organisations Projects Scheme (VOPS).

These projects were successfully implemented by SOS Malta, Malta Judo Foundation and Gozo Tourism Association. Amongst them these voluntary organisations received the amount of €83,000.00. The project managed by the MJF had the aim of inclusion of several types of special needs children and youths in the participation of Judo training sessions with other athletes. The target groups were youths and children with Social and Intellectual disorders, the visually impaired, and the disadvantaged.

The Gozo Tourism Association undertook a research focusing mainly on the owners of the tourist establishments, employees, students and other stakeholders that have a direct interest in the tourist industry on Gozo.

The third project undertaken by Solidarity Overseas Service Malta (SOS Malta) has developed an innovative community based response to the needs of vulnerable elderly people to ensure a reduction of their social exclusion, whilst contributing to a reawakening of the spirit of self-giving and active citizenship within the community through the development of a local volunteer scheme.

he Civil Society Fund 2018 OPENED on Monday 23rd July 2018 and the deadline to submit applications is the 20th September 2018 till noon.

Interested applicants may submit a proposal that corresponds to the following eligible actions:

**Action 1:** The affiliation of CSOs to European umbrella organisations, grouping, federations, confederations or networks. and/or

**Action 2:** Attendance at conferences, seminars and meetings abroad in relation to affiliations in European umbrella organisations, groupings, federations, confederations or networks and participation in Training Abroad related to EU Policy or Programmes.


#### **HOW IT WORKS**
