National Volunteer Award 2021

The Malta Council for the Voluntary Sector held its annual event The **National Volunteer Award 2021**. This year the Award was held under the patronage of H.E. President George Vella, in the presence of the Hon. Dr Clifton Grima, Parliamentary Secretary for Sport, Recreation and Voluntary Organisations, Mr. Robert Farrugia, Deputy Chairperson at MCVS, as well as Mr. Jesmond Saliba, Commissioner for Voluntary Organisations. The National Volunteer Awards were categorized into four awards, the **Youth Volunteer Award**, the **Corporate Volunteer Award**, the **Volunteer Organisation Award** and the **National Volunteer Award**.

The **National Volunteer Awards** serves as acknowledging the service done by the volunteers and Voluntary Organisations. Such acts within the community should be recognised, as well as inspire others to participate in a noble cause. Role models are crucial for our youth and society, therefore by recognizing their contributions we can portray how exemplary values towards a common goal reaps benefits for society as a whole.

The **National Volunteer Award**'s aim is to reward individual volunteers who have contributed in any field, such as social, humanitarian, health, ecological, cultural, education, sports, etc. In order to achieve such a reward, the voluntary work must have had a positive contribution towards an institution as well as an inspiration to others. This year's National Volunteer Award went to **Ms Angelique Lofaro from Nature Trust Malta**.

The **Volunteer Organisation Award** is a reward to a Voluntary Organisation that has been distinguished in its sector, while also being both inventive in its approach and services within the community, was awarded to **Mosta Cycling Club**.

The **Corporate Volunteer Award** is awarded to a Company or Organisation coming from the Private Sector which has given tangible support, as well as facilitating its employees to volunteer. This year it was awarded to **EYETECH LTD**.

The **Youth Volunteer Award** which is awarded to a Volunteer between the age of 16 and 30 years that made a remarkable impact in the youth community was awarded to **Ms Ylenia Zammit**, a volunteer with **The Malta Rabbit Club**.

Parliament Secretary, the Hon. Clifton Grima, while thanking those who contribute towards society, explained that events and days like today are proof of how the voluntary in our society has increased throughout the years, and it has become such a dynamic and alive sector. Dr Grima claimed how the reform VO Plus will be building upon the national strategy for voluntary and will be preparing the sector not only for present challenges but also for the future. He proclaimed that it is his personal mission as well as the government's to collaborate with the Malta Council for the Voluntary Sector to continue sustaining the voluntary sector in its services, which is considered an essential element in our society.

In his speech Mr Robert Farrugia, Deputy Chairperson of the Malta Council of the Voluntary Sector, acknowledged how despite we are celebrating the voluntary, a volunteer does not work for payment, not even praise. Sometimes they are not even expecting merit. However Mr Farrugia truly believes that society should be grateful for this contribution, and also treasure their services because otherwise without voluntary work in our society we wouldn't be where we are today.

The President, H.E. Dr. George Vella thanked all voluntary organisations on behalf of the nation for their continuous work during these difficult times since the outbreak of the COVID-19 pandemic, continuing to offer their services as they did before or in different ways, and doing their utmost to continue to achieve their goals. President Vella noted that the voluntary sector covers every field, thus helping from both the socio-economic aspect and in terms of the innovative and inclusive development of the country. This is also recognised by the United Nations, which insists that when people are encouraged to offer ideas on how to solve specific issues, the solutions usually offered by the voluntary sector are more feasible and sustainable. For his last remark, the President thanked the Malta Council for the Voluntary Sector for once again recognising the efforts made by this sector, as well as all those who have been rewarded for their beneficial work in society.

Fl-ahħar kumment tieghu, il-President radd ħajr lill-Kunsill Malti għas-Sett tal-Volontarjat li, għal sena oħra, għarraf jagħti r-rikonoxximent tiegħu lil dan is-settur, kif ukoll lil dawk kollha li ġew ippremjati għall-ġid li ħolqu permezz ta' ħidmiethom.
