Invitation to local NGOs and IGM for Conference on Young People and Information

One of the Strategic Objectives of the Ministry for Foreign and European Affairs and Trade's strategy is the enhancement of cooperation with the OSCE to strengthen democratic institutions and human rights, including media freedom.

In line with this, with the participation of the OSCE Representative on Freedom of the Media, the Ministry will be organising a Conference on Young People and Information, taking place on 10-11 November at the Hotel Excelsior.

The conference will be bringing together young people as well as academics and media professionals from the OSCE region and the OSCE Mediterranean Partners for Cooperation to will brainstorm to propose solutions to challenges linked to the dissemination of information online. Participants will also be invited to engage with the invited speakers and develop a draft "manifesto for policymakers". The topics which will be dealt in the conference are: 1) addressing media freedoms; 2) combating mis-and-disinformation; 3) tackling online discrimination.
